CHANGE TO BEST OF BREED

DOGS WHICH ACCORDING TO THEIR OWNER'S RECORDS HAVE COMPLETED THE REQUIREMENTS FOR A CHAMPIONSHIP AFTER CLOSING OF ENTRIES FOR THE SHOW, BUT WHOSE CHAMPIONSHIPS ARE UNCONFIRMED (AKC RULES, CHAPTER 11, SECTION 6), MAY BE TRANSFERRED FROM ONE OF THE REGULAR CLASSES TO THE BEST OF BREED COMPETITION, PROVIDED THIS TRANSFER IS MADE BY THE SHOW SECRETARY AT LEAST ONE HALF HOUR PRIOR TO THE START OF ANY REGULAR CONFORMATION JUDGING AT THE SHOW.

DAY-OF-SHOW PARKING GUIDELINES

Some parking areas may be some distance from your ring(s). **An unloading area will be provided.** Please follow the instructions of parking attendants. Day-of-Show parking will be \$8.00 per space. Vehicles requiring more than one space (motor homes, etc.) will be parked in the day-of-show overflow parking lot and will be charged \$8.00 per space used. **No setups or x-pens will be allowed in day-of-show parking lots.** No overnight parking will be allowed in the day of show parking lots. **Anyone not following KCPS rules risks having his/her vehicle towed at owners' expense. No abusive behavior will be tolerated.**

Overnight parking is not permitted on the streets in Indio.

DIRECTIONS TO THE SHOW SITE

IN SOUTHERN CALIFORNIA, TRAVEL INTERSTATE 10, EXIT AT MONROE STREET IN THE CITY OF INDIRIO. TRAVEL SOUTH ON MONROE ABOUT FOUR (4) MILES TO PAST AVENUE 50 FOR DAY OF SHOW PARKING. TURN RIGHT INTO EMPIRE POLO CLUB SHOW SITE AND FOLLOW SIGNS.

ALL OFFICIALS AND EXHIBITORS WITH OVERNIGHT PARKING RESERVATIONS ENTER AT AVENUE 51 (JUST PAST AVENUE 50) OFF MONROE.
